The National Survey of Area Agencies on Aging

- Survey was open September to December 2022
- Survey administered to all AAAs (over 600)
- One response per AAA
- 74 percent response rate




Core AAA Services

All AAAs provide:







- 28 percent of AAAs are the transportation providers
- 73 percent of AAAs contract with local providers for transportation services



Transportation Service Options are Increasing

Transportation Service	2022 Percentage (n=445)	2019 Percentage (n=489)
Any transportation service	91	89
Non-medical transportation	76	65
Assisted transportation (e.g., curb-to-curb, door-to-door, door-through-door)	75	74
Wheelchair-accessible transportation service	60	53
Medical transportation/NEMT	54	41
Transportation information and referral/assistance	36	34
Volunteer transportation program	30	29
Transportation vouchers	27	21
Travel planning	23	Not asked
Partnerships with housing sites	16	Not asked
Driver refresher trainings	12	9
Partnerships with rideshare companies	12	5

Transportation Partnerships

- 45 percent of AAAs partner with transportation providers for social engagement programs
- 83 percent of AAAs have either a formal or informal partnership with transportation agencies
 - Transportation agencies were one of the most common types of new or expanded partnerships that AAAs reported after COVID

Staff Positions


- 39 percent of AAAs have a transportation coordinator/mobility manager on staff and 10 percent say that they need to hire one in the next 5 years
- 5 percent of AAAs have a travel trainer and 7 percent say that they need to hire one in next 5 years






