Week of August 12:

In addition to assessing what you're seeing, think about what changes you'd recommend!

- Develop a pedestrian-related policy recommendation
- Identify and describe a pedestrian improvement project
- Develop an implementation plan for establishing a pedestrian advisory group
- Write a plan and event schedule for a community group walking assessment
