# Technical Assistance Brief •

## **Dual Eligibility for Medicare and Medicaid**

The National Aging and Disability Transportation Center (NADTC) promotes the availability and accessibility of transportation options that meet the needs of older adults, people with disabilities, and caregivers.

**Medicare** is a health insurance benefit provided by the federal government for older adults and individuals with disabilities. There are no financial requirements or restrictions for Medicare. **Medicaid** is a medical assistance program provided by partnership of states and the federal government for individuals with low-income of any age. Eligibility is determined by both financial and non-financial requirements. Both programs provide a variety of medical benefits with qualifying criteria. Benefits include approved doctor visits, hospitalization and skilled nursing facility care and transportation. Persons who are eligible for both Medicare and Medicaid benefits are known as "dual eligible" or "Medicare-Medicaid enrollees". (Aging, 2023)

This technical assistance brief provides resources to increase understanding of both programs and what transportation benefits are available for those who are dually eligible for Medicare and Medicaid.

## **Medicare and Medicare Advantage**

Original Medicare plans (Part A and B) only cover emergency ambulance transportation services. Medicare Part B covers transportation services when the transportation is needed for medical emergencies or when traveling in other vehicles would cause

more danger for the patient. It also covers emergency transportation for airplane or helicopter services if ground transportation is not fast enough. Original Medicare does not cover non-emergency transportation services for routine health care appointments. (Burford, 2022) Medicare Advantage Plans, often referred to as "Part C" or "MA Plans", are offered by Medicare-approved private insurance companies that must follow established Medicare policy and procedures. Some Medicare Advantage plans cover non-



emergency medical transportation (NEMT). These trips may require prior approval. The Medicare website offers the opportunity to compare Medicare Advantage plans and can help determine the transportation benefits in each plan. Some Medicare Advantage plans offer reliable transportation options for members going to medical or related treatments, pharmacies, and other services to promote health and wellness. In 2020, the Center for Medicare and Medicaid Services (CMS) allowed Medicare Advantage Plans the flexibility to offer transportation for members seeking preventative and wellness services, including trips to the grocery store and other approved destinations.

#### **Understanding Half Fare/Reduced Fare Requirements**

Public transportation law, 49 U.S.C. 5307(c)(1)(D), requires public transportation agencies that receive Federal Transit Administration (FTA) funding under the Section 5307 Urbanized Area Formula Program to offer half fare or reduced fare to people with disabilities and older adults who present a Medicare card during off-peak hours for fixed-route services. ## **Medicaid**

Non-Emergency Medical Transportation (NEMT) is a mandatory benefit for Medicaid recipients. The benefit provides free transportation to and from approved medical services. The NEMT requirement was not law but an interpretation via regulation and subject to interpretation, elimination, or waivers, until December of 2020. The Consolidated Appropriations Act of 2021, Section 209 of H.R. 133 (P.L. 116-260),

codified the Medicaid NEMT benefit into law (https://bit.ly/3XN6UuY). Because Medicaid is administered by each state, the benefits depend on the state of residency rules. In addition, how members access these benefits will vary. Some states contract with a third-party brokerage firm to coordinate beneficiary transportation while others provide fee-for-service reimbursements, mileage reimbursement or public transit vouchers.

Federal regulations added the assurance of transportation by requiring State Medicaid agencies to ensure necessary transportation for clients to and from providers and to describe the methods that the agency will use to meet this requirement. This regulation requires agencies to include this information in the State Medicaid plan.

## **Dual Eligibility**

Dual eligibility allows recipients to use Original Medicare or Medicare Advantage and Medicaid Transportation Benefits. Plans may vary on trip eligibility and how the trips are scheduled. Recipients should contact their Medicare or Medicare Advantage provider with questions relating to their transportation benefits. Contact your state's Medicaid agency with questions on Medicaid Transportation benefits because they vary by state.
